# Terms and Conditions – "Secrets in the City" Downtown Tauranga Promotion 2017

These Terms and Conditions relate to the 'Secrets in the City" Downtown Tauranga Promotion (the Competition") run by Mainstreet Tauranga Inc ("the Promoter").

By entering the "Secrets in the City" Downtown Tauranga Promotion you agree to be bound by the terms and conditions set out below.

#### How to Enter:
