

Terms and Conditions – “Win a Diamond” Downtown Tauranga Promotion during Taste Tauranga 2020

These Terms and Conditions relate to the ‘Win a Diamond’ Downtown Tauranga Promotion during the Taste Tauranga festival 2020 (the Competition”) run by Mainstreet Tauranga Inc (“the Promoter”).

By entering the “Win a Diamond” Downtown Tauranga Promotion you agree to be bound by the terms and conditions set out below.

How to Enter:

1. The Competition can be entered by dining at any participating “Win a Diamond” business between 9 October – 25 October 2020 during the Taste Tauranga festival 2020 and spending \$100 or more.
2. Participating “Win a Diamond” restaurants, bars and cafes are:

3. Only if the purchase amount is \$100 or more at any participating “Win a Diamond” restaurant will the purchaser qualify to be awarded a cubic zirconia. **The purchaser must take their cubic zirconia to Peet Jewellers at 2/136 Willow Street, Tauranga, before the 27 October 2020 to go in the draw to win the \$5000 diamond.**
4. Purchasers name and number will be collected at point of sale for possible follow up if they have not taken their cubic zirconia in to Peet Jewellers in time to go in the draw to win the \$5k diamond.
5. Only one cubic zirconia will be given per table bill that is \$100 or more at any participating business.
6. The purchaser is required to provide their details including their name, address, phone number to Peet Jewellers to go in the draw to win the prize
7. Competition closes at 11:59pm, Sunday 25 October 2020 for cubic zirconias being given out at participating businesses. The purchaser has until **Tuesday 27 October 5pm** to register with Peet Jewellers.
8. The entrant must be that of an individual person (not a business, family or syndicate).
9. There are only 1500cubic zirconias available during this promotion, with 100 total available at each participating business. Once each business has given out their 100 cubic zirconias, there will be no more to win from that establishment. Check availability at chosen establishment when booking.

10. There is one prize to be won and the winner will be drawn on Thursday 29 October 2020.
11. From all the entries one winner will be drawn and the winner will win a diamond from Peet Jewellers.
12. The diamond is valued at \$5000.
13. The Prize is not exchangeable or redeemable for cash.

Conditions:

14. The Promoter or Peet Jewellers will notify the winner. If the winner cannot be contacted and their identity verified to the Promoter's satisfaction within 3 days, the winner's entry will be void and another winner drawn.
