

Terms and Conditions – "Trustpower Toi Tauranga - The Great Gingerbread Hunt 2021"

These Terms and Conditions relate to The Great Gingerbread Hunt during Downtown Tauranga's Trustpower Toi Tauranga Christmas held on Saturday 4th December, Saturday 11th December and Saturday 18th December 2021 run by Mainstreet Tauranga Inc ("the Promoter").

By entering The Great Gingerbread Hunt, you and your child agree to be bound by the terms and conditions set out below:

How to Enter:

- 1. You need to reserve a free ticket through Eventbrite here https://www.eventbrite.co.nz/e/the-great-gingerbread-hunt-tickets-213362301387
- 2. You need to select which date you wish to attend (Saturday 4th, 11th, or 18th December 2021)
- 3. You need to select tickets in the available time slots
- 4. On the day you need to report to the registration tent on the Downtown Tauranga Waterfront where you will be asked to scan or sign in, show your ticket/s, and receive your official map to The Great Gingerbread Hunt
- 5. Follow the 19 clues and make your way around the city centre looking for the hidden Gingerbread Men
- 6. Next to each clue write the letter shown on the Gingerbread Man's button in the box provided
- Once you have completed all 19 clues write each letter in order in the boxes at the bottom of the entry form to form a phrase
- 8. Write your name, phone number, and contact email on the entry form and post it in the competition letterbox in Red Square by no later than 8am Monday morning after the Saturday you completed The Great Gingerbread Hunt
- 9. Each Monday after The Great Gingerbread Hunt all the entries will be collected from the official competition letterbox and a winner will be randomly drawn to win a prize
- 10. The entrant must be that of an individual person (not a business, family, or syndicate)
- 11. There is one prize drawn each week (for the three weeks)
- 12. The winners will be notified on each corresponding Monday and once the winner is confirmed it will be announced through Downtown Tauranga's social media
