

# Terms and Conditions – “Perfect Day” Downtown Tauranga Competition 2017

These Terms and Conditions relate to the “Perfect Day” Downtown Tauranga Competition (“the Competition”) run by Mainstreet Tauranga Inc (“the Promoter”).

By entering the “Perfect Day” Downtown Tauranga Competition you agree to be bound by the Terms and Conditions set out below.

## **How to Enter:**

1. The Competition can only be entered by tagging someone on Facebook that you would like to spend the Perfect Day with on the original Facebook post on the Downtown Tauranga page (Downtown Tauranga)
2. The competition can be entered between Wednesday 16<sup>th</sup> August 2017 and Monday 16<sup>th</sup> October 2017.
3. Competition closes at midnight on Monday 16<sup>th</sup> October 2017.

## **The Winner:**

4. One winner will be drawn randomly from the list of correct entries received by the Promoter.
5. The winner must be that of an individual person (not a business, family or syndicate).
6. The winner must be able to collect the prize in person, providing proof of identity to the satisfaction of the Promoter when collecting the prize.
7. The Promoter will notify the winner via private message on Facebook. If the winner cannot be contacted and their identity verified to the Promoter’s satisfaction within 2 working days, the winner’s entry will be void and another winner drawn.

## **Prize:**
