

# Terms and Conditions – “Shop to Win” Downtown Tauranga Promotion 2018

These Terms and Conditions relate to the ‘Shop to Win’ Downtown Tauranga Promotion (the Competition”) run by Mainstreet Tauranga Inc (“the Promoter”).

By entering the “Shop to Win” Downtown Tauranga Promotion you agree to be bound by the terms and conditions set out below.

## **How to Enter:**

1. The Competition can be entered by making a purchase in any participating Downtown Tauranga business and filling out a Shop to Win entry form between Friday 1 June 2018 – end of business Tuesday 31 July 2018. You can enter by;
2. Any purchase amount qualifies for an entry in the competition if the purchase is made from a participating business and the purchaser completes an official entry form with details including their name, address, phone number.
3. Competition closes at the end of Tuesday 31<sup>st</sup> July 2018.
4. The entrant must be that of an individual person (not a business, family or syndicate).

## **Prize:**

5. There is one prize to be won and the winner will be drawn on Monday 6<sup>th</sup> August 2018.
6. From all the entries one winner will be drawn and the winner will win a \$2,000 shopping spree in Downtown Tauranga. The total prize package is valued at \$2000.00.
7. The prize consists of \$2,000.00 worth of vouchers from Downtown Tauranga businesses of the winner’s choice OR \$2000 worth of Downtown Tauranga vouchers OR a mixture of both.
8. The Prize is not exchangeable or redeemable for cash.
9. The winner must be available to do a shopping spree with a representative from Downtown Tauranga on a pre-arranged day in August. The winner must give the Downtown Tauranga representative an indication of the stores they wish to visit on the pre-arranged day, at least one week before so arrangements can be made.

16. Where an email address has been supplied these details may be added to the Downtown Tauranga Customer Database and you may from time to time receive Emailers from the Promoter (unless you have indicated differently). You can opt out of receiving these emailers at any time.

To the extent permitted by law, the Promoter and its employees and agents will not be liable for any claims, damages, injuries, costs and expenses suffered, sustained or incurred (including but not limited to indirect or consequential) as a result of, or arising out of, or in any way connected with this competition and/or the Prize.
18. The Promoter is not liable for any tax implications that may arise as a result of winning the prize.
19. The Promoter's decision regarding the winner is final and binding – no correspondence will be entered into.
20. The Promoter in the Promoter's sole discretion reserves the right to cancel, terminate, modify or suspend this competition at any time and for any reason.
