

# Terms and Conditions – “Best Place” Downtown Tauranga Promotion 2018

By entering the “Best Place” Downtown Tauranga Promotion (“the Competition”) you agree to be bound by the terms and conditions set out below.

## How to Enter:

1. The Competition can be entered by voting for your “Best Place” Downtown Tauranga between Saturday 1<sup>st</sup> September and Sunday 30 September 2018. You can enter by;
2. Visiting the Downtown Tauranga website ([www.downtowntauranga.co.nz](http://www.downtowntauranga.co.nz)) and following the link on the home page to vote for your “Best Place” OR
3. Visiting the Downtown Tauranga Facebook page ‘like’ our page and vote for your “Best Place” OR
4. Completing a voting form provided in the Downtown Tauranga businesses
5. Competition closes at the end of Sunday 30<sup>th</sup> September 2018
6. “Best Place” can be a shop, business, cafe, restaurant or a service provider.
7. The entrant must be those of an individual person (not a business, family or syndicate).
8. During the promotion the top ten businesses as they have been voted by the public may from time to time be reported on the Downtown Tauranga facebook page and Downtown Tauranga website.
9. By entering the competition you agree that any comments or quotes placed with your vote can be used for promotional activity by the promoter including but not limited to your name being linked with the comment or quote.
10. Your vote must be for a business in Downtown Tauranga.
