Terms and Conditions – "Taste Tauranga Burger Competition"

- 5. You can only vote for a burger that is part of the Taste Tauranga Burger Competition otherwise your entry is invalid

- There is one prize to be won for a voter in the burger competition and the winner will be drawn on Tuesday 3rd September 2019
- From all the entries one winner will be drawn and the winner will win \$300 worth of Downtown Tauranga dining vouchers.
